

3. The school shall charghe fees and funds as declared to the appropriateauthority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed reciepts of fees/funds to the students.

Salary shall be paid as per declaration at the time of seeking recognition. 4.

No capitation fee and other charges shall be charged from the children/parents.
