curriculum planning, infrastructure, resources, physical education, staff development and other co-curricular areas.

The school will strictly adhere to all rules regarding safety of students including Fire fighting and Transportation, etc. Further, school will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilities for boys and girls separately in proportion to the number of students.

From the academic session commencing from 01.04.2020, the number of sections in the school are restricted as per appendix - V of affiliation 8. bye laws from the next session and shall not be increased without specific approval of the Board. Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class XII examinations from the year mentioned while granting affiliation/upgradation regularly without break or inform with reasons thereof in writing well in time about the nonsponsoring of the candidates.

Running of coaching institutions in the school premises in the pretext of providing coaching to the students for various examinations is not 15. permitted by the Board. Strict action would be taken on defaulters.

The Manger and the Principal of the school shall be jointly responsible for the authenticity of the online/offline documents/ information/data

16. submitted by the School to the Board. Apart from rules to be adhered to by the school as mentioned above for drawing specific attention of the school authorities, the school authorities

are required to acquaint themselves with all the rules contained in Affiliation & Examination Bye-laws and circulars/guidelines/notification issued by the Board from time to time.
